

### Official Rules for "Free Fuel For A Year"

1. **NO PURCHASE NECESSARY. VOID WHERE PROHIBITED BY LAW:** THE "FREE FUEL FOR A YEAR" SWEEPSTAKES ("THE SWEEPSTAKES") IS SPONSORED BY MID-ATLANTIC COOPERATIVE SOLUTIONS, INC. D/B/A AERO ENERGY AND WISE OIL AND PROPANE (THE "SPONSOR"). THE SWEEPSTAKES STARTS AT 12:00:01 AM EASTERN TIME ("ET") ON JUNE 1, 2010 AND CLOSES AT 11:59:59 PM ET ON AUGUST 31, 2010 (THE "SWEEPSTAKES PERIOD"). ALL REFERENCES IN THESE RULES ARE EASTERN TIME, WHICH SHALL CONTROL FOR ALL PURPOSES OF THIS SWEEPSTAKES.
2. **ELIGIBILITY:** THE SWEEPSTAKES IS OPEN TO RESIDENTIAL PROPANE AND HEATING OIL CUSTOMERS ONLY WITH DELIVERY IN PENNSYLVANIA, MARYLAND, DELAWARE, AND VIRGINIA LOCATED WITHIN THE SERVICE DELIVERY AREA OF THE SPONSOR, WHO HAVE REACHED THE AGE OF EIGHTEEN (18) AT TIME OF ENTRY AND POSSES A VALID DRIVER'S LICENSE. THE SPONSOR RESERVES THE RIGHT IN ITS SOLE DISCRETION TO DISQUALIFY ANY INDIVIDUAL WHO IS FOUND TO BE TAMPERING WITH THE ENTRY PROCESS OR THE OPERATION OF THE SWEEPSTAKES OR THE SWEEPSTAKES WEBSITE, TO BE ACTING IN VIOLATION OF THESE OFFICIAL RULES, OR TO BE ACTING IN A DISRUPTIVE MANNER, OR WITH THE INTENT TO DISRUPT OR UNDERMINE THE LEGITIMATE OPERATION OF THE SWEEPSTAKES, OR TO ANNOY, ABUSE, THREATEN OR HARASS ANY OTHER PERSON, AND THE SPONSOR RESERVES THE RIGHT TO SEEK DAMAGES AND OTHER REMEDIES FROM ANY SUCH PERSON TO THE FULLEST EXTENT PERMITTED BY LAW. THE SPONSOR RESERVES THE RIGHT TO MODIFY, EXTEND, SUSPEND, OR TERMINATE THE SWEEPSTAKES IF IT DETERMINES, IN ITS SOLE DISCRETION, THAT THE SWEEPSTAKES IS TECHNICALLY IMPAIRED OR CORRUPTED OR THAT FRAUD OR TECHNICAL PROBLEMS, FAILURES OR MALFUNCTIONS OR OTHER CAUSES HAVE DESTROYED OR SEVERELY UNDERMINED OR TO ANY DEGREE IMPAIRED THE INTEGRITY, ADMINISTRATION, SECURITY, PROPER PLAY AND/OR FEASIBILITY OF THE SWEEPSTAKES. IN THE EVENT THAT THE SPONSOR IS PREVENTED FROM AWARDING PRIZES OR CONTINUING WITH THE SWEEPSTAKES AS CONTEMPLATED HEREIN BY ANY EVENT BEYOND ITS CONTROL, INCLUDING BUT NOT LIMITED TO FIRE, FLOOD, NATURAL OR MAN-MADE EPIDEMIC OF HEALTH OF OTHER MEANS, EARTHQUAKE, EXPLOSION, LABOR DISPUTE OR STRIKE, ACT OF GOD OR PUBLIC ENEMY, SATELLITE OR EQUIPMENT FAILURE, RIOT OR CIVIL DISTURBANCE, TERRORIST THREAT OR ACTIVITY, WAR (DECLARED OR UNDECLARED) OR ANY FEDERAL STATE/PROVINCE OR LOCAL GOVERNMENT LAW, ORDER, OR REGULATION, PUBLIC HEALTH CRISIS, ORDER OF ANY COURT OR JURISDICTION, OR OTHER CAUSE NOT REASONABLY WITHIN THE SPONSOR'S CONTROL (EACH A "FORCE MAJEURE" EVENT OR OCCURRENCE), THEN SUBJECT TO ANY GOVERNMENTAL APPROVAL WHICH MAY BE REQUIRED, THE SPONSOR SHALL HAVE THE RIGHT TO MODIFY, SUSPEND, OR TERMINATE THE SWEEPSTAKES. THE INVALIDITY OR UNENFORCEABILITY OF ANY PROVISION OF THESE OFFICIAL RULES SHALL NOT AFFECT THE VALIDITY OR ENFORCEABILITY OF ANY OTHER PROVISION.
